PEREGRINE US MANAGED VOLATILITY EQUITY FUND R (USD)

INVESTMENT OBJECTIVE AND POLICY

The investment objective of the Peregrine US Managed Volatility Equity Fund ("the fund") is to seek equity-based capital growth with less risk than long-only equities over the long term whilst preserving capital over the shorter to medium term. The intention is that growth be predominantly of a capital nature with income largely reinvested. The fund aims to achieve outperformance of the US Dollar benchmark which is 40% US Cash plus 60% S&P 500 Index. To achieve this investment objective the fund will invest primarily in US listed equity investments, index futures and options on index futures. The portfolio is permanently hedged in varying degrees which aims to reduce volatility and minimise the impact of falling equity prices and markets. The fund will seek to protect downside risk through utilising permanent hedging mechanisms using derivative instruments. The fund may also use derivative instruments for the purpose of efficient portfolio management.

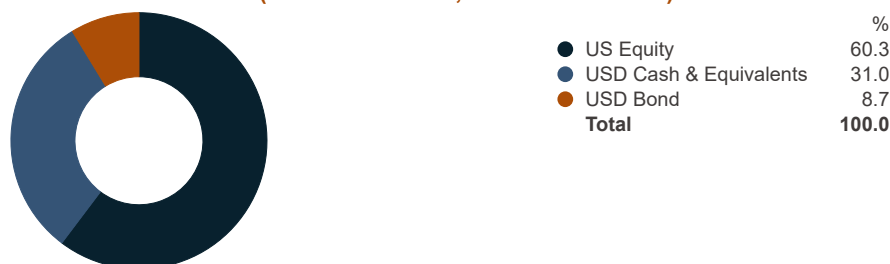

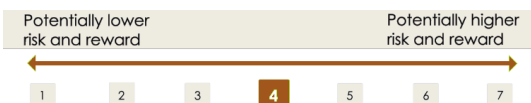
ASSET ALLOCATION (MARKET VALUE, LOOK THROUGH)

The fund invests in a combination of US listed equity securities or funds, cash and money market instruments and CME listed derivatives. In terms of the above risk reward profile, the portfolio has a medium to higher risk rating due to the nature of its strategy which is to combine equity market exposure, via lower risk beta strategies, with permanent hedging in order to reduce volatility and the extent of potential drawdowns on equity positions. The portfolio may be subject to risks which include, but are not limited to, adverse political and macroeconomic events, creditworthiness of issuers and significant corporate events, as well as interest rate conditions and currency fluctuations.

INVESTMENT ADVISOR COMMENTARY

Global equity markets extended their gains in May, even as geopolitical tensions continued to weigh on the macroeconomic backdrop. Persistently elevated oil prices kept energy-driven inflation concerns in focus, complicating the path for global central banks. Credible attempts at a US–Iran agreement raised the prospects of a resolution, though negotiations remained ongoing. Despite these headwinds, global equities maintained a risk-on phase, led by continued rotation into artificial intelligence (AI) related stocks. The MSCI World Index (in US dollars) returned 4.6% for the month. The S&P500 Index gained 5.2% and the Nasdaq Composite advanced 8.4%, with both indices reaching all-time highs supported by a strong earnings season. European equities also advanced, with the MSCI Europe Index (in US dollars) rising 2.6%. The MSCI Emerging Markets Index (in US dollars) gained 9.7%, driven by continued strength in technology and semiconductor stocks.

The Peregrine US Managed Volatility Equity Fund ('the fund') was up 3.0% for the month, as its benchmark delivered 3.3%. The strategy tends to lag during strong market advances and remains defensively positioned as valuations continue to appear stretched.

About the fund and custodian

This fund is a separate cell of Peregrine Global Funds PCC Limited ("the company"), a protected cell company registered in Guernsey, registration number 54802, and authorised by the Guernsey Financial Services Commission ("GFSC") under the Protection of Investors (Bailiwick of Guernsey) Law, 2020 and the Authorised Collective Investment Schemes (Class B) Rules and Guidance, 2021. The fund has also been approved by the Financial Sector Conduct Authority in terms of section 65 of the Collective Investment Schemes Control Act, 2002. H4 Collective Investments (RF) (Pty) Ltd is the South African representative for this fund. The custodian of the fund is Northern Trust (Guernsey) Limited (tel: +44 1481 745 000) and the administrator is Northern Trust International Fund Administration Services (Guernsey) Limited.

About the manager and investment advisor

The company has appointed Peregrine Guernsey Limited (the "manager"), registration number 36784, as the principal manager and investment manager of the fund. The manager's registered address is PO Box 255, Trafalgar Court, Les Banques, St Peter Port, Guernsey, C.I., GY1 3QL (tel: +44 1481 758 600). The manager is licensed by the GFSC as an investment manager. Peregrine Guernsey Limited is a subsidiary of Citadel Holdings (RF) (Pty) Ltd. The company has also appointed Citadel Investment Services Proprietary Limited ("Citadel"), registration number 1996/006847/07, as the investment advisor of the fund. Citadel is licensed as a financial services provider in terms of the Financial Advisory and Intermediary Services Act, 2002. Citadel Asset Management (Pty) Ltd is the asset management division of Citadel.

Risk warning

If this fund has exposure to derivatives, this fact and the level of exposure will be specified within this document. Where this fund invests in other funds which use derivatives, those underlying derivative exposures will not be contained in this document. Derivatives derive their value from the value of an underlying asset. Investing in derivatives involves risk because depending on how the derivative is structured, the fund's losses or gains may be unlimited. To prevent this, the fund's derivative positions must be "covered" at all times. This means that the fund must always hold the underlying asset on which the derivative is based, or have sufficient cash or "margin" to deliver if the fund's derivative positions move against it. If derivatives are used in this fund, the cash/cash equivalent shown in the asset allocation section includes the portion allocated to "margin" for covering derivative positions and such portion of cash/cash equivalent is therefore not available for use by the manager. Other asset classes shown in the asset allocation section represent the market value of those assets and must be read together with the derivative holdings disclosure. The use of derivatives in collective investment schemes is governed by regulation. Derivatives can be used only for efficiency in portfolio management, for increasing a fund's yield, or to protect the fund against losses if the value of the shares or instruments invested in, or the market, falls. They may not be used for speculating or for enhancing the return of the fund by using gearing. The most common derivatives are options (puts and calls) and futures.

Ongoing Charges and Total Expense Ratio (TER)

The Ongoing Charges figure is calculated in accordance with the Committee of European Securities Regulators guidelines. The TER is a measure of the fund's assets that have been expended as payment for services rendered in the management of the fund, expressed as a percentage of the average daily value of the fund, calculated over a period of a financial year by the manager.

General disclosures

With respect to South African investors, this document is the minimum disclosure document required by Board Notice 92 of 2014 published by the Financial Sector Conduct Authority under the Collective Investment Schemes Control Act 45 of 2002. Calculation of the NAV and price
