PEREGRINE US MANAGED VOLATILITY EQUITY FUND R (ZAR HEDGED)

INVESTMENT OBJECTIVE AND POLICY

The investment objective of the Peregrine US Managed Volatility Equity Fund ("the fund") is to seek equity-based capital growth with less risk than long-only equities over the long term whilst preserving capital over the shorter to medium term. The intention is that growth be predominantly of a capital nature with income largely reinvested. The fund aims to achieve outperformance of the US Dollar benchmark which is 40% US Cash plus 60% S&P 500 Index, 50% hedged to ZAR. To achieve this investment objective the fund will invest primarily in US listed equity investments, index futures and options on index futures. The portfolio is permanently hedged in varying degrees which aims to reduce volatility and minimise the impact of falling equity prices and markets. The fund will seek to protect downside risk through utilising permanent hedging mechanisms using derivative instruments. The fund may also use derivative instruments for the purpose of efficient portfolio management.

The Manager seeks to enhance returns of the fund by implementing and varying USD/ZAR currency hedging based on the Manager's view of the relevant currency position ("dynamic hedging").

The fund invests in a combination of US listed equity securities or funds, cash and money market instruments and CME listed derivatives. In terms of the above risk reward profile, the portfolio has a medium to higher risk rating due to the nature of its strategy which is to combine equity market exposure, via lower risk beta strategies, with permanent hedging in order to reduce volatility and the extent of potential drawdowns on equity positions. INVESTMENT ADVISOR COMMENTARY

Global equity markets delivered exceptional returns in the second quarter of 2026, recovering sharply from a geopolitically driven sell-off in March/April. Escalating US–Iran tensions and fears of oil supply disruption through the Strait of Hormuz triggered a broad risk-off move in early April. From that point, equities rallied strongly through the remainder of the quarter, with the S&P 500 Index gaining 15.1% and the Nasdaq Composite surging 21.6%. The MSCI World Index advanced 13.8% (in US dollars) while the MSCI Emerging Markets Index posted 24.1%, its strongest quarterly return since 2009, supported by improved global trade sentiment, and momentum in Asian technology and consumer sectors. Government bonds delivered modest positive returns, with the Bloomberg US Treasury Index gaining 0.3% over the quarter, as the combination of the US Federal Reserve's decision to hold interest rates steady and residual inflation uncertainty kept yields from declining materially.

The ZAR hedged share class of the Peregrine US Managed Volatility Equity Fund ('the fund') was up 5.7% for the quarter as its benchmark delivered 7.2%. The fund's dynamic currency hedging detracted from performance for the quarter but has added value since inception of the strategy.

About the fund and custodian

This fund is a separate cell of Peregrine Global Funds PCC Limited ("the company"), a protected cell company registered in Guernsey, registration number 54802, and authorised by the Guernsey Financial Services Commission ("GFSC") under the Protection of Investors (Bailiwick of Guernsey) Law, 2020 and the Authorised Collective Investment Schemes (Class B) Rules and Guidance, 2021. The fund has also been approved by the Financial Sector Conduct Authority in terms of section 65 of the Collective Investment Schemes Control Act, 2002. H4 Collective Investments (RF) (Pty) Ltd is the South African representative for this fund. The custodian of the fund is Northern Trust (Guernsey) Limited (tel: +44 1481 745 000) and the administrator is Northern Trust International Fund Administration Services (Guernsey) Limited.

About the manager and investment advisor

The company has appointed Peregrine Guernsey Limited (the "manager"), registration number 36784, as the principal manager and investment manager of the fund. The manager's registered address is PO Box 255, Trafalgar Court, Les Banques, St Peter Port, Guernsey, C.I., GY1 3QL (tel: +44 1481 758 600). The manager is licensed by the GFSC as an investment manager. Peregrine Guernsey Limited is a subsidiary of Citadel Holdings (RF) (Pty) Ltd. The company has also appointed Citadel Investment Services Proprietary Limited ("Citadel"), registration number 1996/006847/07, as the investment advisor of the fund. Citadel is licensed as a financial services provider in terms of the Financial Advisory and Intermediary Services Act, 2002. Citadel Asset Management (Pty) Ltd is the asset management division of Citadel.

Risk warning

Where this fund invests in other funds which use derivatives, those underlying derivative exposures will not be contained in this document. Derivatives derive their value from the value of an underlying asset. To prevent this, the fund's derivative positions must be "covered" at all times. This means that the fund must always hold the underlying asset on which the derivative is based, or have sufficient cash or "margin" to deliver if the fund's derivative positions move against it. If derivatives are used in this fund, the cash/cash equivalent shown in the asset allocation section includes the portion allocated to "margin" for covering derivative positions and such portion of cash/cash equivalent is therefore not available for use by the manager. Other asset classes shown in the asset allocation section represent the market value of those assets and must be read together with the derivative holdings disclosure. The use of derivatives in collective investment schemes is governed by regulation. Derivatives can be used only for efficiency in portfolio management, for increasing a fund's yield, or to protect the fund against losses if the value of the shares or instruments invested in, or the market, falls. They may not be used for speculating or for enhancing the return of the fund by using gearing. The most common derivatives are options (puts and calls) and futures.

Ongoing Charges and Total Expense Ratio (TER)

The Ongoing Charges figure is calculated in accordance with the Committee of European Securities Regulators guidelines. The TER is a measure of the fund's assets that have been expended as payment for services rendered in the management of the fund, expressed as a percentage of the average daily value of the fund, calculated over a period of a financial year by the manager.

General disclosures

The value of participatory interests is calculated on a NAV basis.
